THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3430' N07°00'E FROM THE SOUTHWEST CORNER OF SECTION 30, TOWNSHIP 23 NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 & SW 1/4 Sec. 30 T.23N. R.51E. MDM&B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N NORTH DIRECTION, AND 1450 FEET IN A/S SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
