THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3520' N79°00'E FROM THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 30 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 19 & NE 1/4 Sec. 30 T. 23 N. R. 31 E. NDM 8 B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N NORTH DIRECTION, AND 1450 FEET IN A/S SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
