THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3080' N45°30'W FROM THE SOUTH WEST CORNER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 SEC 23 T.23N. R.50E. MDM&B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN NORTH DIRECTION, AND 1450 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
