THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 770' N13°00'E FROM THE SOUTHWEST CORNER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 SEC 23 & SW 1/4 SEC 24 T23N. R50E. MDMEB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N SOUTH DIRECTION, AND 1450 FEET IN A/N NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
