THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 3910' N 20°30'E FROM THE SOUTH WEST CORNER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 & SW 1/4 Sec 24 T. 23 N. R. 50 E. MDM & B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N NORTH DIRECTION, AND 1450 FEET IN A/S SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
