THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4680' N 36° 30' W FROM THE SOUTHWEST CORNER OF SECTION 24, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 NE 1/4 Sec 23 T23N. R50E. MDM&B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN SOUTH DIRECTION, AND 1450 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
