THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 4040' S 14°00' W FROM THE NORTHEAST CORNER OF SECTION 14, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 SEC 14 & NE 1/4 SEC 23 T.23N. R.50E. MDMER. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/H NORTH DIRECTION, AND 1450 FEET IN A/H SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.

THE SURFACE BOUNDARIES OF THE CLAIM ARE DESCRIBED AS BEGINNING AT THE DISCOVERY MONUMENT AND RUNNING THENCE NORTH 50 FEET TO THE CENTER OF THE NORTH END LINE, AND THE TRUE POINT OF BEGINNING, THENCE (CLOCKWISE) EAST 300 FEET TO CORNER NO. 2, THENCE SOUTH 750 FEET TO CORNER NO. 3, THENCE SOUTH 750 FEET TO CORNER NO. 4, THENCE WEST 600 FEET TO CORNER NO. 5, THENCE NORTH 750 FEET TO CORNER NO. 6, THENCE NORTH 750 FEET TO CORNER NO. 1, THENCE EAST 300 FEET TO THE POINT OF BEGINNING.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.S.R. SECTION 517.030.
