THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 5890' S25°30'45"E FROM THE NORTHEAST CORNER OF SECTION 14, TOWNSHIP 23 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SW 1/4 Sec. 13 & NW 1/4 Sec. 24 T. 23 N. R. 50 E. MDM & B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN SOUTH DIRECTION, AND 1450 FEET IN A/AN NORTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
