THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 7890' N64°30'W FROM THE SOUTHWEST CORNER OF SECTION 30, TOWNSHIP 23 NORTH, RANGE 51 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC 26 T.23N. R.50E. MDM & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N NORTH DIRECTION, AND 1450 FEET IN A/S SOUTH DIRECTION, AND 75 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS FEET WIDE AND FEET LONG.
