THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY NORTH 4450' ± WEST 2100' FROM THE SOUTHWEST CORNER OF SECTION 4, TOWNSHIP 23 1/2 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE 1/4 SEC 5 T 23 1/2 N. R. 50 E. MDM&B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N NORTH DIRECTION, AND 1450 FEET IN A/S SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
