THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY NORTH 4450' & EAST 900' FROM THE SOUTHWEST CORNER OF SECTION 4, TOWNSHIP 23 1/2 NORTH, RANGE 50 EAST, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NW 1/4 SEC. 4 T. 23 1/2 N. R. 50 E. MDM & B. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN NORTH DIRECTION, AND 1450 FEET IN A/AN SOUTH DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1,500 FEET LONG.
