## MEMORANDUM OF AGREEMENT

NOTICE IS HEREBY GIVEN that ELMER F. SCHROEDER and ELEANOR RUTH SCHROEDER, his wife, (hereinafter referred to as "OWNER") and FREEPORT-McMoRan GOLD COMPANY, a Delaware corporation, (hereinafter referred to as "FREEPORT") have entered into an Agreement dated as of June 20, 1986, (hereinafter referred to as the "Agreement") covering certain properties located in the State of Nevada, more particularly described in Schedule A attached hereto and made a part hereof (hereinafter referred to as the "Property").

Said Agreement, in consideration of the payments and other covenants and agreements set forth therein, provides that OWNER has leased exclusively to FREEPORT, and FREEPORT has the exclusive right to enter upon and take immediate possession of the Property, to explore and prospect for all metals, ores, minerals, mineral substances and materials of all kinds from the Property. OWNER has granted FREEPORT the exclusive option to purchase the Property at any time while this Agreement is in effect.

The term of said Agreement commenced on the date thereof and shall continue for a period of ten (10) years unless sooner terminated. FREEPORT has the right at any time to terminate said Agreement on ten (10) day's notice in writing to OWNER.

Said Agreement further provides that if OWNER should receive a bona fide offer to purchase the Property at any time during the term of the Agreement, OWNER shall give notice to FREEPORT of such fact and FREEPORT shall have the option for a period of two (2) months after such notice to

purchase the Property from OWNER on the terms and conditions specified in the original notice to FREEPORT from the Selling Party. Any assignment by OWNER of any interest in the Property shall be subject and subordinate to FREEPORT's right of first refusal and to the other rights and interests of FREEPORT under said Agreement.
