CERTIFICATE OF LOCATION  
LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the RC 5 Lode Mining claim in the following quarter section(s) SE 1, SW 1 of Section(s) 20; 21 Township 35 N., Range 50 E., M.D.B.&M., in the unknown Mining District, in Eureka County in the State of Nevada, on the 14th day of May, 1986.

The claim is 1400 feet long and 600 feet wide, such that 20 feet is claimed in a West direction and 1380 feet in a East direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the West to the East direction.

The definition of the boundaries of the claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 16th day of May, 1986.
