THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2880' S 30° W FROM the NW corner Section 1, TOWNSHIP 23N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 2 T23N R50E MDN. FROM THIS DISCOVERY MONUMENT THE UNDERIGNED CLAIMS 50 FEET IN A/AN S 2° 24' 30" E DIRECTION, AND 1450 FEET IN A/AN N 2° 24' 30" W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.R.S. SECTION 517.030.
