THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1575' N71°W FROM NW corner of Sec 1, TOWNSHIP 23N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE SE 1/4 Sec 2 T23 1/2 N R50E MDMB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 150 FEET IN A/AN N2°24'30"W DIRECTION, AND 50 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
