SE 1/4 Sec 2 T23 1/2 N R50E MDM.
FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N S2°24'30"E
DIRECTION, AND 1450 FEET IN A/N N2°24'30"W DIRECTION,
AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600
