THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2225' S 33°W FROM the SE corner Sec 34, TOWNSHIP 24N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE & SE 1/4's Sec 2 T23 1/2 N R 50E MDM 1 B FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N2°24'30"W DIRECTION, AND 1450 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 4 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY N.R.S. SECTION 517.030.
