THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1950' S19°W FROM the SE cor Sec 34, TOWNSHIP 24N RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NE & SE 1/4's Sec 2 T23 1/2 N R50E MOM 13 FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN N2°24'30"W DIRECTION, AND 1450 FEET IN A/AN S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
