THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1850' S22°W FROM the SE corner of Sec 34, TOWNSHIP 24N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. AND SAID CLAIM LIES WITHIN THE NE 1/4 Sec 2 T23 1/2 N R 50E MDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S2°24'30"W DIRECTION, AND 1450 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
