AND SAID CLAIM LIES WITHIN THE the SE 1/4 sec 34 T24N R50E AND NE 1/4 Sec 2 T23 1/2 N R50E HDM. FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/AN S2°24'30"W DIRECTION, AND 1450 FEET IN A/AN N2°24'30"W DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
