THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 2690' N6°W FROM the SE corner Sec 34 T24N R50E RANGE, MOUNT DIABLO MERIDIAN, NEVADA, AND SAID CLAIM LIES WITHIN THE NET SE 1/4s Sec 34 AND the NW & SW 1/4s Sec 35 T24N R50E MDMB FROM THIS DISCOVERY MONUMENT THE UNDERSIGNED CLAIMS 50 FEET IN A/N N2°24'30"W DIRECTION, AND 1450 FEET IN A/N S2°24'30"E DIRECTION, AND 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
