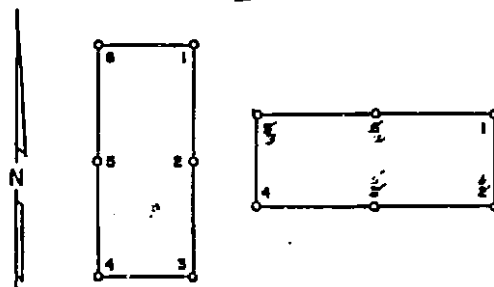

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS, INC., by its Agent, the undersigned, does hereby locate the Wt 137 Lode Mining Claim on this 1st day of July, 1986, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE)(NW)(SW) (Quarter) Section(s) 34(34)(35)(35), Township 23 N., Range 50 E., Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a South direction to Post No. 2,  
Thence, 750 feet in a West direction to Post No. 3,  
Thence, 750 feet in a West direction to Post No. 4,  
Thence, 600 feet in a North direction to Post No. 5,  
Thence, 750 feet in a East direction to Post No. 2,

the point of beginning and all posts being 3" X 4' plastic pipe.
