AFFIDAVIT OF ANNUAL ASSESSMENT WORK

The undersigned, being a duly authorized agent of the owners of the unpatented mining claims hereinafter described and acting on behalf of such owners states:

That Nabob Silver-Lead Co. and Lucky Three Mining Co. are the owners of all of those certain unpatented mining claims situate in Eureka County, Nevada and more particularly described as situated in Sections 15 and 22, T20N, R52E, consisting of 20 lode claims in a contiguous claim group known as OJO I thru OJO 20, as filed in the Eureka County official records and BLM numbers NMC 334040-334051; NMC 339956-339959 and NMC 345784-345787 filed with the BLM in Reno, Nevada.


That all of the aforesaid work and improvements were performed solely at the expense of the owners above named.


