

NOTICE OF LIEN

NOTICE IS HEREBY GIVEN THAT TOM NORRIS, INC., ("Claimant") claims a mechanic and materialmen's lien upon all of the real property ("Property") situated in the Counties of Elko and Eureka, State of Nevada, more particularly described as follows:

PARCEL 1: (ELKO COUNTY)

Sage Hen Patented Mining Claims #2, 3, 5, 6 and 7 at the Rossi Mine, Ivanhoe Mining District in Elko County, Nevada.

TOGETHER WITH all improvements situate thereon.

PARCEL 2: (EUREKA COUNTY)

A tract of land within the SW $\frac{1}{4}$  of Section 23 and N $\frac{1}{2}$  of Section 26, Township 33 North, Range 48 East, MDM, Eureka County, Nevada, as depicted on that Record of Survey Map on file in the Office of Eureka County Recorder, File No. 66359, Official Records, and more particularly described as follows:

Beginning at a point on the northwesterly right-of-way line of former U.S. Highway 40, from which the SE corner of said Section 26 bears South 15°55'20" East, 3924.18 feet as Corner #1;

thence along said right-of-way line South 67°58'49" West, 33.54 feet to Corner #2, also being the most easterly corner of that parcel of land described in Eureka County Deeds, Book 23, page 176;

thence continuing along the boundary of said parcel North 78°59'00" West, 695.42 feet to Corner #3;

thence continuing along said parcel North 58°01'30" West, 223.70 feet to Corner #4;

thence continuing along said parcel North 65°39'30" West, 96.30 feet to Corner #5;

thence continuing along said parcel South 82°36'30" West, 234.00 feet to Corner #6;

thence continuing along said parcel North 78°59'00" West, 346.85 feet to Corner #7;

thence continuing along said parcel South 11°01'00" West, 102.20 feet to Corner #8, also being a point on the northerly 150 foot right-of-way line of the Western Pacific Railroad;

thence along said right-of-way line North 78°59'00" West, 1537.06 feet to Corner #9;

thence departing said right-of-way North 11°01'00" East, 1212.27 feet to Corner #10;

thence South 78°59'00" East, 1779.99 feet to Corner #11;

thence South 11°01'00" West, 372.64 feet to Corner #12;

thence South 78°59'00" East, 704.06 feet to Corner #13;

thence South 7°27'24" East, 595.73 feet to Corner #14;

thence South 56°57'24" East, 496.78 feet to Corner #1, the point of beginning.

TOGETHER WITH all improvements situate thereon.

CLAIMANT FURTHER STATES THAT:

1. Claimant's demand, after deducting all just credits and offsets, is the sum of \$7,028,000.00, together with interest accruing thereon at the legal rate of interest of 12% per annum from the date the aforesaid monies became due, together with costs and reasonable attorney's fees;

2. The name of the owner or reputed owner of the Property, so far as is known to Claimant, is N L INDUSTRIES, INC.;

3. The name of the person by whom Claimant was employed, or to whom Claimant furnished the material is N L INDUSTRIES, INC.;

4. The materials and labor were furnished by the Claimant pursuant to contracts to strip, mine and haul barite ore from the Owner's mine to the Owner's millsite. The original contract was entered into on or about February 5, 1983 and was renewed on or about February 5, 1986. The original contract as renewed, has no specific duration. Pursuant to the contracts the Claimant stripped, mined, and hauled approximately 368,000 tons of ore at \$17.25 per ton, for which the Claimant is unpaid. Payments for barite were to be made upon use of the ore, as defined in contracts. That Claimant also stripped approximately 50,000 tons of ore at \$10.00 per ton, and partially mined approximately 120,000 tons at \$1.50 per ton, but was prevented

from stockpiling by N L INDUSTRIES, INC. For this the Claimant is unpaid.

5. The date of Claimant's last performance under the contract was June 18, 1986.
