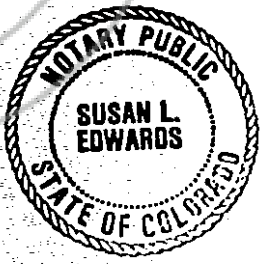

SUMMARY REPORT

This detailed report is filed in compliance with the requirements of Title 30 U.S.C. 28-1 for those claims shown by Exhibit "A".

The work consisted of geologic mapping, stream sediment sampling and a soil sampling program along with related activities during the period June through August, 1986. The work was done to further evaluate the potential for valuable mineral deposits and assist in further exploration and development work.

The work was performed by or under the supervision of Michael B. Mehrtens, a geologist with twenty-nine years experience with a Ph.D. (Geochemistry) degree from School of Mines, London, U.K.; John W. Cox, a geologist with eight years of experience with a M.S. (Geology) Degree from MacKay School of Mines, Reno, NV and Richard B. Milne, a geologist with fourteen years of experience with a B.A. (Geology) Degree from Western State College, Gunnison, CO.

An exploration program consisting of further geologic studies and exploratory drilling is under consideration for this property. All technical data resulting from the sampling program and related activities are in the possession of U.S. Minerals Exploration Company (aka USMX of Nevada, Inc.).

Mineralized and altered trends were identified by the mapping and sampling program which underlie portions of the claim group.
