

TO ALL WHOM IT MAY CONCERN:

Freeport-McMoRan Gold Company, a Delaware corporation, by and through its lawful and authorized agent, Barry K. Bradshaw, gives notice that it claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing its rights, states and certifies as follows:

1. That the locator is a corporation lawfully organized and existing under the laws of the State of Delaware, United States of America.
2. The name of the claim is DRY NO. 26.
3. The name and current mailing address of the locator is Freeport-McMoRan Gold Company, P. O. Box 41330, Reno, Nevada 89504.
4. The date of location is the 8th day of July, 1986.
5. The claim is 1500 feet long and 600 feet wide, such that 1490 feet is claimed in an easterly direction and 10 feet in a westerly direction from the discovery monument, and which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is easterly as nearly as may be determined.
6. The location work consisted of making maps as provided by NRS 517.040.

8. Corner No. 1 (the NW corner) of this claim bears North 4750 feet and West 4450 feet from the Southeast Corner of Section 28, T. 30 N., R. 49 E., M.D.B.&M.
