

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a Northerly direction and 750 feet in a Southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the Northeast to the Southwest.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by 3" or 4" x 5' PVC Pipe ink inscribed

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 3" or 4" x 5' PVC Pipe inked SW corner Aerie #139
- Corner No. 2 is a 3" or 4" x 5' PVC Pipe inked W side corner Aerie #139
- Corner No. 3 is a 3" or 4" x 5' PVC Pipe inked NW corner Aerie #139
- Corner No. 4 is a 3" or 4" x 5' PVC Pipe inked NE corner Aerie #139
- Corner No. 5 is a 3" or 4" x 5' PVC Pipe inked E side corner Aerie #139
- Corner No. 6 is a 3" or 4" x 5' PVC Pipe inked SE corner Aerie #139

The monumentation and marking of the corners was completed by the 3rd day of August, 1986.
(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Esmeralda County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
