

MECHANIC'S LIEN

NOTICE IS HEREBY GIVEN that pursuant to the Nevada Statutes, Western States Energy, Inc., hereinafter referred to as "Claimant," claims a lien upon the real property and buildings, improvements or structures thereon, described in paragraph five (5) below, and states the following:

1. That demand of Claimant after deducting all just credits and offsets, is Forty-one Thousand Eight Hundred Twenty-nine and 47/100ths Dollars (\$41,829.47) together with interest thereon at the rate of eighteen percent (18%) per annum from September 9, 1986.

2. That the name of the owner or reputed owner of said property, is Precambrian Exploration, Inc., which has leased the same to Tonkin Springs Gold Mining Company, a wholly owned subsidiary of Silver States Mining Corporation.

3. That Claimant did from August 9, 1986, until September 16, 1986, perform labor and/or supply materials as follows: supplied explosive products for blasting utilized by owner's agent, Target Construction, Inc., in its mining operations, for the construction, alteration or repair of said buildings as follows: Fourteen Thousand Two Hundred Thirty-nine and 24/100ths Dollars (\$14,239.24) of material on August 9, 1986, pursuant to Invoice No. 086290 dated August 25, 1986; Eight Thousand Two Hundred Twenty-two and 38/100ths Dollars (\$8,222.38) of material on August 20, 1986, pursuant to Invoice No. 086066 dated August 25, 1986; Eleven Thousand Four Hundred Fifty-two and 99/100ths Dollars (\$11,452.99) of material on August 30, 1986, pursuant to Invoice

No. 086 315 dated September 17, 1986; One Thousand Thirty-three and 60/100ths Dollars (\$1,033.60) of material on September 12, 1986, pursuant to Invoice No. 086 365 dated September 24, 1986; and Six Thousand Eight Hundred Eighty-one and 26/100ths Dollars (\$6,881.26) of material on September 16, 1986, pursuant to Invoice No. 086 375 dated September 24, 1986. Said materials were utilized for the improvements or structures, which materials were in fact used in the construction, alteration or repair of said buildings, improvements or structures, the location of which is set forth in paragraph five (5) below.

4. Claimant furnished work and materials at the request of Earl Feggert, owner, and Vernon Hooper, job superintendent, for Target Construction, Inc.

5. That the property upon which said lien is sought to be charged is situated near the City of Eureka, County of Eureka, State of Nevada, commonly known as the Tonkin Springs Project--Mining Claim and more particularly described as the Tonkin Springs Project, Tonkin Springs Gold Mining Company, Mining Claim and/or Township 24, Range 49 East, Sections 30 and 31, according to the official records of Eureka County, State of Nevada.
