LODE CLAIM

The undersigned, hereby certifies that he has located a mining claim in the Unnamed Mining District, County of Eureka, State of Nevada, on a vein or lode known as the Vinini. The name of this claim is Lyndall #118.

The general course of said lode or vein, as near as it may be described, is North and South.

The locator Claim 5 20 feet in a North direction and 1480 feet in a South direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The location and description of each corner with the markings thereon are as follows:

The Northeast corner is marked by a 4" ^{dia.} x 4" post 4 1/2 feet high inscribed NE corner of Lyndall #118, the Northwest corner is marked by a 4" ^{dia.} x 4" post 4 1/2 feet high inscribed NW corner of Lyndall #118, the Southeast corner is marked by a 4" ^{dia.} x 4" post 4 1/2 feet high inscribed SE corner of Lyndall #118, the Southwest corner is marked by a 4" ^{dia.} x 4" post 4 1/2 feet high inscribed SW corner of Lyndall #118. There is a 4" ^{dia.} x 4" post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since August 30, 1986. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the appropriate fees have been paid to the county recorder.
