To tie this claim to the Public Survey, begin at the southeast corner of Section  
 32, Township 26 North, Range 48 East, Mount Diablo Meridian, thence  
North 7120', Thence West 3000'  
 to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing  
 ledge, lode or vein, extending 1450 feet from the location monument in a  
west direction and 20 feet in a easterly  
 direction, together with 300 feet on each side of the center of the ledge for  
 the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3"x4' PVC pipe  
 monuments firmly set in the ground bearing applicable designation. The description of such  
 claim is: Beginning at Corner No.1, the Northeast Corner; thence,

South 600' to the southeast corner, a 3"x4' in length PVC pipe, thence,  
 West 750' to the south side center a 3"x4' in length PVC pipe, thence,  
 West 750' to the southwest corner, a 3"x4' in length PVC pipe, thence,  
 North 600' to the northwest corner, a 3"x4' in length PVC pipe, thence,  
 East 750' to the north side center a 3"x4' in length PVC pipe, thence,  
 East 750' to the northeast corner, a 3"x4' in length PVC pipe, the point  
 and place of beginning.

The monumentation and marking of the corners was completed by the 19th day of  
 September, 1986.
