 to Corner No. 1, the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing
 ledge, lode or vein, extending 20 feet from the location monument in a
Westerly direction and 1450 feet in a easterly
 direction, together with 300 feet on each side of the center of the ledge for
 the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3"x4" PVC pipe
 monuments firmly set in the ground bearing applicable designation. The description of such
 claim is: Beginning at Corner No. 1, the Northeast Corner; thence,

South 600' to the southeast corner, a 3"x4" in length PVC pipe, thence,
