NOTICE AND CLAIM OF LIEN

- 6. That a demand for payment has been made by lien claimant and that ONE MILLION FOUR HUNDRED NINETY FIVE THOUSAND ONE HUNDRED FIFTY NINE and 60/100 DOLLARS (\$1,495,159.60) has
