The general course of said vein being Westerly and Easterly with 1,490 feet claimed in a Westerly direction and 10 feet in an Easterly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Mt. Hope Mining District, County of Eureka, State of Nevada and is located in all or in part of the following 1/4 Section(s):
