9 said ROBERT KURTZBACH ever since has been, and still is, the duly  
10 appointed, qualified and acting Executor of the Estate of WILLARD  
11 E. KRUEGER, also known as WILLARD KRUEGER, also known as WILLARD

14 That Notice to Creditors was published in the Eureka


