## RIGHT OF WAY GRANT

A portion of the Northeast one-quarter (NEt) of Section 31, T32N, R49E, MDB&M, Eureka

An easement 15.0 feet in width, 7.5 feet lying each side of the following described centerline:

Commencing at the Southwest corner of said Section 31, from which the Southwest corner of Section 36, T32N, R48E, MDB&M bears West;

Thence North 39°14'24" East, 4261.68 feet, to an existing pole (#101833), the centerline of an existing Sierra Pacific powerline, the true point of beginning:
