WITNESSETH:

That the said party of the first part, in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents quit claim and convey unto the party of the second part, and to its successors and assigns forever, all the rights of the party of the first part to divert water and water rights appurtenant to the land situated in the County of Eureka, State of Nevada, that is described in Exhibit "1", attached hereto and made a part hereof.

To have and to hold the said water and water rights together with the tenements, hereditaments and appurtenances thereof unto the second party, its successors and assigns, forever.

Second party does hereby agree to assume the payment of all Division of Water Resources, Nevada State Engineer fees and charges that may hereafter become due and payable in respect to said rights, referred to in the above first paragraph.
