THIS IS TO CERTIFY that the BIS No. 8 lode mining claim was located by:

The general course of said vein being Westerly and Easterly with 1,490 feet claimed in a Westerly direction and 10 feet in an Easterly direction from the Discovery Monument, at which the Notice of Location is posted.
