THIS IS TO CERTIFY that the BIS No. 11 lode mining claim was located by:

The general course of said vein being Northeasterly and Southwesterly with 1,490 feet claimed in a Northeasterly direction and 10 feet in a Southwesterly direction from the Discovery Monument, at which the Notice of Location is posted.
