THIS IS TO CERTIFY that the SAM No. 7 mill site was located by:

Said locator claims, under and by virtue of the mining laws of the United States of America and the State of Nevada, 330 feet in an Easterly direction and 660 feet in a Southerly direction from the Location Monument, at which the Notice of Location is posted, and contains 5 acres more or less.

Said mill site is located in conjunction with the following lode claims: BIS Nos. 1 - 27; VAN Nos. 1 - 8, 12 and 13; NAV Nos. 6 - 8; and SAND Nos. 1 - 3, situated in the Unknown Mining District, County of Eureka, State of Nevada, and is located in all or in part of the following 1/4 Section(s):

To tie this mill site to the Public Survey, begin at the Northeast Corner of Section 1, Township 15 N., Range 52 E., Mount Diablo Base and Meridian, thence South, approximately 2,640 feet and West, approximately 3,300 feet to the Northwest corner (Cor. No. 1) of this mill site.

The exterior boundaries of this mill site are clearly marked by substantial 4 inch diameter x 4 1/2 foot long post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such mill site is:

Beginning at the Location Monument (Corner No. 1 and the Northwest Corner),

thence, East, 330 feet to the Northeast Corner (Cor. No. 2),

thence, South, 660 feet to the Southeast Corner (Cor. No. 4),

thence, West, 330 feet to the Southwest Corner (Cor. No. 5),

thence, North, 660 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.
