Said claim is located in the NE/4 of Sec. 34, Twp. 17 North, Range 50 East.

Beginning at Corner No. 1, the Northeast corner, which is located N. 43°45' W., 4,601 feet from the U.S. Geological Survey Brass Cap (1954), Elevation 6389, within the SW 1/4 Section 35, Township 17 North, Range 50 East, Mount Diablo Meridian; thence,

S. 45° E., 600 feet to the SE Corner, a PVC pipe 3" in dia. x 5' in length; thence,  
S. 45° W., 750 feet to the SS Center, a PVC pipe 3" in dia. x 5' in length; thence,  
S. 45° W., 750 feet to the SW Corner, a PVC pipe 3" in dia. x 5' in length; thence,  
N. 45° W., 600 feet to the NW Corner, a PVC pipe 3" in dia. x 5' in length; thence,  
N. 45° E., 750 feet to the NS Center, a PVC pipe 3" in dia. x 5' in length; thence,  
N. 45° E., 750 feet to the NE Corner, a PVC pipe 3" in dia. x 5' in length, the point  
and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a Northeasterly direction, and 10 feet in a Southwesterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 13th day of February, 1987.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$20.75 lode claim filing fee has been paid to the County Recorder.
