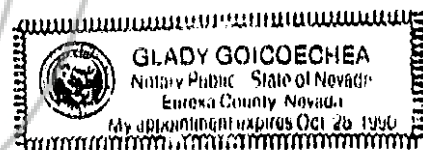

EXHIBIT "A"

Bankruptcy Clause:

The commencement of any proceeding under the bankruptcy or insolvency laws by or against the Grantor or the maker of the note secured hereby; or the appointment of receiver for any of the assets of the Grantor hereof or the maker of the note secured hereby, or the making by the Grantor or the maker of the note secured hereby of a general assignment for the benefit of creditors, shall constitute a default under this Deed of Trust.

Partial Releases:

Grantor and Beneficiary have agreed that providing Grantor is not in default under any of his obligations hereunder, Grantor shall be entitled to release provisions as follows:

Upon payment of \$4,000.00 for each one acre parcel, which shall be in addition to regular monthly installments, Beneficiary shall release any one acre parcel as requested by Grantor, provided subject acre has existing access for ingress and egress.

Prepayments:

There shall be no prepayment penalty for the note secured hereby.
