MEMORANDUM OF EXPLORATION AND MINING AGREEMENT
WITH OPTION TO PURCHASE

NOTICE IS HEREBY GIVEN that MARY M. BISONI, whose mailing address is P.O. Box 152, Eureka, Nevada 89316, and GENEVE BISONI, whose mailing address is P.O. Box 184, Eureka, Nevada 89316, (therein and hereinafter referred to collectively as "Optionor"), and Hecla Mining Company, a Delaware corporation, whose address is 6500 Mineral Drive, P. O. Box C-8000, Coeur d'Alene, Idaho 83814-1931 (therein and hereinafter referred to as "Hecla"), have entered into an Exploration and Mining Agreement with Option to Purchase ("Agreement") effective as of the 15th day of January, 1987, with respect to the mining claims described in Exhibit A attached hereto and by this reference made a part hereof, which mining claims are therein and hereinafter referred to as the "Subject Premises." The Agreement expires at midnight (Pacific Standard Time) on January 15, 2021.

Under the terms of the Agreement, Optionor has granted to Hecla the exclusive possession of and right to enter upon the Subject Premises to explore for, develop, mine, remove and sell any or all Mineral Substances on or under the Subject Premises. The term "Mineral Substances" as used in the Agreement includes, without being limited to, all gold, silver, platinum, iron, copper, molybdenum, vanadium, lead, zinc, cinnabar, bauxite, fluorite, kaolin, diamonds and other precious and semi-precious stones, and all other materials or substances of any nature whatsoever found in natural deposits, whether similar or dissimilar in character to the foregoing minerals, lying in, under or upon the Subject Premises. Optionor has also granted to Hecla the sole, exclusive and irrevocable option to purchase the Subject Premises for a period ending midnight (Pacific Standard Time) on January 15, 2021.

Any assignment of interest under the Agreement shall be made expressly subject to the Agreement and shall require the assignee to assume and agree in writing to perform all of the obligations of the assignor under the Agreement as related to the interest assigned. In case of assignment by mortgage, however, such assumption of obligations shall not be required, but should such mortgage be foreclosed, the purchaser on foreclosure shall take subject to the Agreement. The provisions of the Agreement shall inure to the benefit of and be binding upon the parties and their successors and assigns. No assignment
