

NOTICE AND CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that TEMPFORCE OF SALT LAKE CITY claims a Mechanic's and Materialman's lien upon the property hereinafter particularly described, which property is located in Eureka County, Nevada, and which claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of work, labor, materials and/or services furnished by lien claimant for the improvement of real property hereinafter particularly described, located in the County of Eureka, State of Nevada.

That the whole or real property hereinafter particularly described has been or is in the process of improvement and is reasonably necessary for the convenient use and occupation of said property.

Claimant further states:

1. That the name of the owners or reputed owners of the premises sought to be charged are ATLAS PRECIOUS METALS, INC., or ATLAS GOLD, 743 Horizon Court, Suite 105, Grand Junction, Colorado 81506 and Gold Bar Mine, Three Bars Road, Eureka, Nevada 89316.

2. That the name of the person by whom lien claimant was employed and to whom lien claimant furnished work, labor, materials and/or services in connection with the project is WESTERN ERECTORS, INC., 1640 South 800 West, Woods Cross, Utah 84087, Sub-Contractor to various other known and unknown contractors.

3. That the terms, time given and conditions of the contract were: to supply temporary laborers on said mine project and to pay said laborers wages and also taxes on the wages of said laborers, to be reimbursed by WESTERN ERECTORS, INC.

4. That work, labor, materials and/or services have been furnished to and actually used upon the above-described project in the total amount of \$9,217.20 plus interest, and said amount is now due and owing to lien claimant.

5. That the first labor and materials furnished by lien claimant and incorporated in the project was on or about October 1, 1986 and that the last labor furnished by lien claimant and incorporated in the project was in or about December 15, 1986; and that there are no other just credits or offsets to be deducted and the total amount due and owing to lien claimant is the sum of \$9,217.20, plus interest.

6. That a demand for payment has been made by lien claimant and that no amount has been paid; that there are no further off-sets to the claim and that the sums of \$9,217.20 plus interest is now due and owing to the lien claimant on account of the work, labor materials and/or services furnished as above specified and that the undersigned claims a lien upon the real property particularly described herein for said sum together with interest and attorney's fees as provided by law.

7. That the real property sought to be charged with this Claim of Lien upon which the above described work of improvement has been made is located in the County of Eureka, State of Nevada, and as more
