CERTIFICATE OF LOCATION

The discovery monument is located approximately 2450' feet in a SO2E direction from the South 1/4 corner of Section 1, T26N R48E.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
