CERTIFICATE OF LOCATION  
LODE MINING CLAIM

Orion No. 131 Lode Mining Claim

This is to certify that Orion Ltd. did on the 30th day of December, 1986 locate and claim, and does hereby locate and claim by right of discovery and location, and in compliance with the Mining Laws of the United States and the State of Nevada, and the local customs and rules of the district in which the claim is located, the lode mining claim called the Orion No. 131 mining claim in the:

NE 1/4 of Section 22, T.32N., R.49E., M.D.B. & M.

in the unknown Mining District, Eureka County, State of Nevada.

The general course of the lode or vein as near as can be determined is in a S 89 degrees 59 minutes 32 seconds W direction from the location monument upon which the Notice of Location is posted. The undersigned claims 1495 feet in a S 89 degrees 59 minutes 32 seconds W direction and 5 feet in a N 89 degrees 59 minutes 32 seconds E direction from the location monument together with 300 feet on each side of the center of the vein or lode.

The position of each corner of this claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side center monument are as follow:

No. 1	Northeast Corner	Name & number scribed on metal tag
No. 2	Southeast Corner	Name & number scribed on metal tag
No. 3	South Side Center	Name & number scribed on metal tag
No. 4	Southwest Corner	Name & number scribed on metal tag
No. 5	Northwest Corner	Name & number scribed on metal tag
No. 6	North Side Center	Name & number scribed on metal tag

As erected on the ground, each corner and sideline center monument consists of at least a 3" diameter by 5' white PVC post or a 4" x 4" x 4 1/2' wood post set one foot in the ground and is marked as described above by an aluminum tag attached to the monument. The monumentation and marking of the above-described corners and sideline centers on the ground was completed within 60 days from the date of posting the Notice of Location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040. Said claim map and description has been simultaneously filed herewith, in the County Recorder's office and the Nevada State DLM office and is by reference incorporated herein.
