CERTIFICATE OF LOCATION LODE MINING CLAIM

The undersigned claims 995 feet in a N 89 degrees 59 minutes 32 seconds E direction and 5 feet in a S 89 degrees 59 minutes 32 seconds W direction from the location monument together with 300 feet on each side of the center of the vein or lode.

As erected on the ground, each corner and sideline center monument consists of at least a 3" diameter by 5' white PVC post or a 4" x 4" x 4 1/2' wood post set one foot in the ground and is marked as described above by an aluminum tag attached to the monument. The monumentation and marking of the above-described corners and sideline centers on the ground was completed within 60 days from the date of posting the Notice of Location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040. Said claim map and description has been simultaneously filed herewith, in the County Recorder's office and the Nevada State BLM office and is by reference incorporated herein.
