CERTIFICATE OF LOCATION

The discovery monument is located approximately 1530 feet in a N72W direction from the SW corner of section 35 T23N R5E.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location.
