CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the JASPER 1663 Lode Mining Claim on this 7th day of May, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

The work of location consisted of making the maps as provided in NRS 517.040. Dated May 20 A.D., 1987, and filed in duplicate.

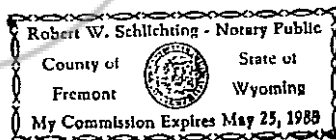
