CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the JASPER 1664 Lode Mining Claim on this 8th day of May, 1987, situated in the Unknown Mining District, Eureka County, Nevada.

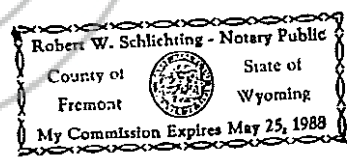
