direction and 10 feet in a Westerly direction, together with  
300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC  
Pipe monuments firmly set in the ground and bearing applicable monument
